



TERMS OF REFERENCE FOR

TRAINING COMMUNITY GROUPS IN 'BEEKEEPING AS A BUSINESS' IN KIRYANDONGO DISTRICT

Background and Context

Wildlife Conservation Society (WCS) is currently implementing a USAID funded project titled "USAID/Uganda Combating Wildlife Crime Activity". In this activity, WCS aims to support community park adjacent communities to mitigate human wildlife conflict as well as develop and enhance income-generating activities to improve community livelihoods. Uganda Wildlife Authority, which manages Murchison Falls Conservation Area (MFCA), including Karuma Wildlife Reserve (KWR) has for long supported park adjacent communities with various income generation projects to reduce dependence on the protected areas' resources and create community incentives to support wildlife conservation. Beekeeping is one of the most prominent enterprises promoted by park management authorities, NGOs and the local governments overlapping KWR. Currently, communities around KWR have received one thousand hives and have set up several apiaries along the park boundary. The apiaries are expected to generate income for the communities and act as deterrents to crop raiding animals, particularly the elephants. These efforts, however, have faced several challenges to the effect that beehives are sometimes abandoned. Further, communities have complained of low bee colonization rates and low returns on investment from the enterprise. On the other hand, beekeeping remains a highly favored, wildlife-friendly enterprise among park authorities, bee experts and NGOs owing to the value and importance attached to its ecological role as pollinators and products like honey, bee wax, bee venom, royal jelly and propolis among others.

Scope of work

The local consultant is expected to conduct training to three (3) community beekeeping groups in Karuma Wildlife Reserve (approx. 50 participants). The training will include but will not limited to the following;

Method of delivery

The required method of delivering the training should be through the following;

- ➤ Theory 10%
- ➤ Brainstorming & Group discussion 40%
- ➤ Practical demonstration 50%

The consultant shall prepare simple, easy to read handouts for the community groups.

In light of the Covid-19 situation in the country, the consultant shall train each of the community groups independently in accordance with the Ministry of Health Covid-19 Standard Operating Procedures.

Time Frame

The consultant is expected to spend a maximum of fifteen (15) days on the assignment including preparation of materials, training and report writing. The consultant shall schedule the training during the harvesting season (September 2021) to help the groups with harvesting.

Qualifications

The suitable consultant must have a bachelor's degree in agriculture/apiculture or related field and at least 7 years of working experience in community development, enterprise development, entrepreneurship, facilitating community meetings and familiar with integrated conservation development programs. The consultant should also be tax compliance (VAT and WHT).

Deliverables

A training report detailing the modules covered and an assessment of levels of comprehension of the topics.

Technical and Financial proposal

The applicant should submit a technical and financial proposal for this work. The financial proposal must have adequate breakdown of expenses such as transport, accommodation, meals for participants etc.
